C. *Transported Semen:* The balance of the stud fee must be paid prior to shipment of semen. Mare owner must put Us on notice 24 hours in advance of requested day of shipment. We will have our veterinarian collect and prepare semen for transport at a cost of \$250.00 per collection, (plus shipping fees by Fed Ex). Mare owner shall be responsible for obtaining any permits required from breed registries other than AHR and must be in order at the time of collection of semen according to applicable registry rules. Mare owner agrees not to hold Us responsible if breed requirements are not met due to improper filing of paperwork by the mare owner. We will handle all permits, payments of fees and filing of documents required by the stallion owner in a timely manner.

Cantrell Arabians agrees to exercise all possible care to insure the mare's safety and well-being while in its care. Cantrell Arabians, their agents or employees shall not be liable for injury, sickness, disability, or death suffered by the mare or any foal, from any cause whatsoever, and owner of the mare specifically agrees to such conditions and waives each and every claim for damages resulting from the injury, sickness, disability or death. Conversely, the mare owner will not be held liable for any disease, injury or accident to the stallion.

A daily mare boarding fee for the 20__ season will be charged at \$12 per day for a dry mare, \$15 per day for a mare with a foal at side. Visiting mares shall be fed alfalfa. Special feeding requirements shall be billed accordingly and agreed upon between all parties when the mare arrives, and special requirements will be noted on this agreement. These and all other expenses such as veterinary and farrier fees will also be due upon receipt. Service certificates required for foal registration will be provided when all fees for care and services have been paid.

It is to the advantage of the mare owner to have the mare examined by their own veterinarian prior to arrival and those findings made available to us at the time of arrival. If the mare has not been examined, it is agreed that We have the option to have the mare examined and a uterine culture taken by a qualified licensed veterinarian at the expense of the mare owner in order to determine the health and breeding condition of the mare. It is also agreed that ovarian examinations and pregnancy examinations performed by manual, rectal palpations and ultrasonography may be made to optimize the chances of conception. It is the policy of Cantrell Arabians to keep costs as low and reasonable as possible and to keep the mare owner informed as to the progress. Mares are usually bred every other day through their heat cycle and are teased to the stallion daily. Breedings will be by artificial insemination on the premises of Cantrell Arabians. The costs of all veterinary examinations, treatments, and inseminations are the responsibility of the Client, and will be billed to the Client by our attending veterinarian. Upon arrival, mares must be current on vaccinations for protection against influenza, rhinopneumonitis, sleeping sickness and tetanus. The horses must be dewormed regularly and will be dewormed every eight weeks. Booster vaccinations must be administered by, and according to the veterinarian's recommendations. If the vaccinations and dewormer have not been administered as required, a veterinarian shall administer as needed at the cost to the mare owner. Mare owner shall provide Us with any information regarding breeding history, health information, food and drug allergies, sensitivities, habits and vices in order to be able to provide the mares and foals with the best possible care.

This contract shall not be assigned or transferred by the mare owner without written consent by Us.

Option to rebreed: If client opts to breed to one of Our stallions the following year, they may do so at a reduced stud fee of \$1200/\$700. That stud fee will remain the same for each consecutive year the client breeds back. If a year is skipped, this offer is null and void and all prices resume to current costs.
